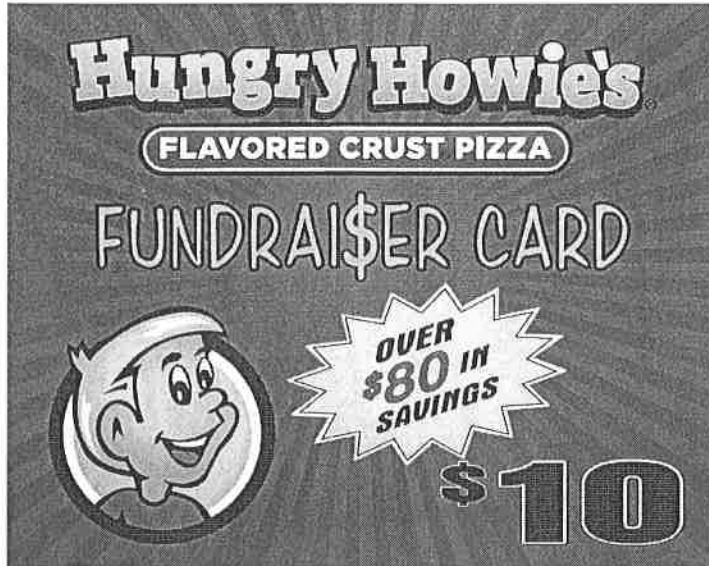

**Climbing Wall Release/Indemnification
of all Claims and Covenant Not to Sue**

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any injury to yourself or your property or for your death arising out of your use of the Climbing Wall, now or any time in the future.

PARENTAL RELEASE for MINORS If I am a PARENT or LEGAL GUARDIAN of a minor climbing at the Westside Community Center YMCA, whether or not I am a member myself, or am present when the minor is climbing, I agree to indemnify and hold harmless the Westside Community Center YMCA and the other parties released, in the event a minor member of the family sues any one of them. I understand this means I will pay all fees, costs, and charges incurred by any party released, including attorney fees.

I HEREBY ACKNOWLEDGE AND AGREE that the sport of rock climbing and the use of the Climbing Wall have *inherent risks*. I have full knowledge of the nature and extent of all the risks associated with rock climbing and the use of the Climbing Wall, including but not limited to:

1. Death, paralysis, and all manner of injury resulting from falls or from hitting rock faces and projections, whether permanently or temporarily in place.;
2. Rope abrasion, entanglement and other injuries resulting from activities on or near the Climbing Wall such as, but not limited to, climbing, belaying, rappelling, lowering on rope, use of rescue systems and any other rope activities;
3. Injuries resulting from falling climbers or dropping items, such as, but not limited to, ropes or climbing hardware;
4. Cuts and abrasions resulting from skin contact with the Climbing Wall;
5. Failure of rope, slings, harnesses, climbing hardware, anchor points, holds, or any part of the Climbing Wall structure.

I acknowledge that this list is not inclusive of all possible risks and in no way limits the extent or reach of this release and covenant not to sue. I also understand that outdoor climbing requires additional skills beyond those learned at indoor climbing facilities and that I agree to seek qualified instruction before attempting to climb outdoors.

Release/Indemnification and Covenant Not to Sue

In consideration of my, or my minor's use of the Climbing Wall, I agree to release and on behalf of myself, my heirs, representatives, executors, administrators, and assigns, HEREBY DO RELEASE Westside Community Center YMCA, its officers, agents, and employees from any cause of action, claim, or demand of any nature whatsoever, including but not limited to, a claim of NEGLIGENCE, which I, my heirs, representatives, executors, administrators and assigns may now have, or have in the future against Westside Community Center YMCA on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to my, or my minor's use of the Climbing Wall whether that use is supervised or unsupervised, however the injury or damage is caused, including, but not limited to the NEGLIGENCE of Westside Community Center YMCA, its officers, agents, and employees.

In consideration of my use of the Climbing Wall, I agree to INDEMNIFY AND HOLD HARMLESS Westside Community Center YMCA, its officers, agents, and employees from any and all causes of action, claims, demands, losses, or costs of any nature whatever arising out of or in any way related to my, or my minor's use of the Climbing Wall.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in the use of the Climbing Wall and that I am voluntarily assuming the risks. I understand that I will be solely responsible for any loss or damage, including death, I sustain while using the Climbing Wall and that by this agreement release Westside Community Center YMCA of any and all liability for such loss, damage, or death.

I further certify that I am in good health and that I have no physical limitations which would preclude my safe use of the Climbing Wall.

Contract to Follow Climbing Wall Safety Policies and Rules

1. I agree to abide by, the following climbing wall safety policies and rules and to explain them to any of my minor Children: All climbers 18 and above must sign a waiver/release form and fill it out completely and legibly. (Parent/Legal Guardian must fill out and sign for minors).
2. Children must be at least 44 inches in height to climb
3. Only water is allowed in the climbing area. No other beverages or food are allowed.
4. During the first come, first serve climbing times, climbers must wait their turn. The last climbers will be announced 15 minutes before the wall is closed.
5. Proper attire must be worn. No dresses, skirts, no open toed/heeled shoes, sandals, winter boots, etc.
6. Staff reserves right to ask for identification and proof of age.
7. No unbelayed climbing above the bouldering line.
8. When belayed by non-staff members, climbers must be roped and belayed through a belay plate. Belays must be anchored. Roped climbers and belayers must wear harnesses.
9. Lead climbing is not allowed. Top- rope climbing only.
10. Inform other climbers and climbing-wall staff of any situation seen as unsafe or not in accordance with Climbing Wall Safety Policies. All climbers are asked to assist and encourage less experienced climbers.
11. Pockets must be emptied of all contents.
12. Headphones or necklaces that could cause entanglement and any jewelry posing a hazard such as unwieldy rings or large earrings must be removed.
13. All accidents or equipment damage must be reported immediately.
14. Belay certification will only be given to persons over the age of 18 upon completion of certification test.
15. Obtain climbing pass from Welcome Center.

Staff, at its discretion, reserves the right to ban use of the Climbing Wall to individuals not adhering to the Climbing Wall Safety Policies and Rules.

Westside Community Center YMCA reserves the right to withdraw the membership of any individual permanently or for a specified period of time for breach of contract in following the Climbing Wall Safety Policies and Rules, or for any conduct that is viewed as unsafe or inappropriate.

In consideration of the use of the Climbing Wall, I acknowledge that I have read and agree to abide by the Climbing Wall Safety Policies and Rules.

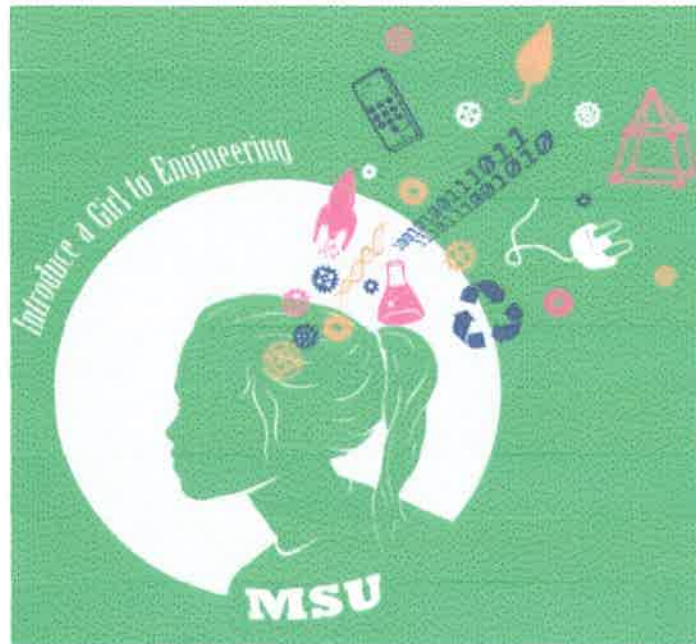
